| <ol style="list-style-type: none"> Open to trucks or cars or ATV's (4-wheelers) 2 or 4 wheel drive. Vehicle must be in good mechanical condition. Only 1 driver per vehicle. No passengers allowed. No pro-arena type vehicles allowed. DOT approved tires only. Must be stock frame. Shocks must be mounted in stock location of that vehicle. After market exhaust allowed. May run open headers. Suspension lift kits allowed. No nitrous oxide, aftermarket super chargers, or turbos. | <ol style="list-style-type: none"> Roll bars, fire extinguisher, neck brace or any approved safety device is strongly recommended. (Roll bars required if vehicle does not have a hard top). Must have seat belt, or racing type harness. D.O.T. helmet required. Drivers must be at least 16 years old. Vehicle must not have any obscene language on it. Drivers must attend driver's meeting prior to the event. Drivers and pit crew must not be drinking or smell of alcohol and drivers must not be using illegal drugs. IDD reserves the right to have Police department check the driver's condition if we feel there is a problem with drugs or alcohol. |

Drivers Read

- It is the driver's responsibility for their vehicles safe operation and safety equipment.
- All vehicles must have operable brakes, throttle returns and an ignition shut off. Helmets and seat belts are required.
- Foul or Abusive Language will NOT be tolerated. Nor will disrespect to other racers, race officials or spectators. Drivers are responsible for their own actions as well as the actions of their pit crews.
- Roll cages and racing type seat belts are recommended.
- It is the driver's responsible to inform track officials in the proper hook up of their vehicle.
- Drivers are responsible for the safe operating condition of their personal vehicle. All loose items should be removed from cab and bed of vehicles as ANYTHING falling out during the race will result in your disqualification.

Race order will be determined at the drivers meeting.

Drivers are expected to go to the staging area and to be ready to race when the Track officials ask you to. Officials will instruct drivers to line up in run order. Drivers will have a ONE (1) minute grace period to be on the line and ready to race. If unable to meet this time frame, they will be disqualified for that run.

All vehicles must come to a COMPLETE STOP after crossing the finish line. Failure to do so will result in disqualification for that run. Failure to comply with the above will result in immediate dismissal from the race, with all monies forfeited.

Runs will be timed and positions will be scored with the quickest time being your scored time.

SPECIAL NOTE TO ALL DRIVERS AND TEAM MEMBERS

Check your vehicle closely before racing. It is imperative that all participants take every precaution to ensure a safe event for both the Driver and the Spectators. Your brakes must be in good working order, and will be tested at tech. Your throttle must work smoothly; your racer must be as safe as possible.
